- 1. You are the administrator of Microsoft Office Project Server 2003 for your company. Your company is running Project Server in a Windows Active Directory domain. Your company employs several external consultants assigned to project tasks within Project Server. These users do not have Windows domain accounts. Instead, they connect to Project Server by using Project Server accounts. In Project Server, you set the Enterprise Resource Pool to synchronize with Active Directory each day. External consultants in the Enterprise Resource Pool can no longer connect to the Project Server. By expending the least administrative effort, you must ensure that external consultants can connect to Project Server by using Microsoft Project Web Access and be assigned tasks in projects. What should you do?
- A. Assign external resources accounts in the Active Directory domain and group with which you will synchronize. Synchronize the Enterprise Resource Pool with the Active Directory again.
- B. Change the Active Directory group to synchronize with the Enterprise Resource Pool. Synchronize the Enterprise Resource Pool with Active Directory again.

- 2. You are the administrator of the Microsoft Enterprise Project Management solution for your company. All employees at your company have user accounts in Active Directory. You install Microsoft Office Project Server 2003 with default settings. You create new Active Directory security groups. You add all Microsoft Office Project Web Access users to those groups according to their roles as defined in the Enterprise Project Management solution. You configure the Project Server groups to connect to the new Active Directory groups. Written company policy dictates that only resources in the Team Member Active Directory security group can be available for project teams. You must configure the Enterprise Project Management solution to maintain this company policy with the least administrative effort. What should you do?
- A. Open the Enterprise Global. Add only users from the Project Server Team Member group to the Resource Sheet.
- B. On the Server Configuration page of Project Web Access, enter the Team Member Active Directory security group in the Active Directory Enterprise Resource Pool Synchronization Options dialog box.
- C. Add the Project Server Team Member group to the My Resources category. Click the Update Now button for Active Directory synchronization.
- D. Use the Import Resources to the Enterprise wizard for all Project Web Access users. Add only resources to the Project Server Team Member group.

3. You are the administrator of Microsoft Office Project Server 2003 for your company. You install Microsoft SQL Server 2000 on ServerX. ServerX stores the Project Server database. The Project Server database and transaction logs are backed up to a remote server at 2:00 A.M. every day. There are 36 gigabytes (GB) of hard drive space allocated on ServerX for database and log files. Your company has 900 active projects and 1,200 completed projects. Team members update their progress on tasks in Microsoft Office Project Web Access every Friday before 5:00 P.M. One thousand team members are added as resources in Project Server. On a Friday afternoon, users report they cannot make changes to Project Server data. The Event Viewer application log on ServerX contains several error entries just prior to the reported problems that say, "Event ID 2013: The disk is at or near capacity. You may need to delete some files." Your company has a freeze on new hardware acquisitions. Without purchasing new hardware, you must reconfigure ServerX to ensure that team members are able to make changes to Project Server data, and you must prevent similar errors from occuring in the future. What should you do?

A. Back up the transaction log. Modify the backup schedule so that the transaction log is backed up every hour.

- B. Clear the Temp directory. Empty the Recycle Bin. Modify the settings for the Recycle Bin on the data and log disk to remove deleted files immediately without moving them to the Recycle Bin.

- 4. You are the administrator of the Microsoft Enterprise Project Management solution for your company. You back up the Microsoft Office Project Server 2003 database to disk each night. You also back up the transaction logs to disk every two hours. A project manager completes work on a project and realizes that he has completely changed the project schedule. He asks you to restore his project to its previous state. You need to recover the project but minimize data loss to other projects. What should you do?
